- 2 The Statutory Auditors have carried out Limited Review of the Financial Results of the company for the quarter ended June 30, 2022 under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The Statutory Auditors have expressed an unmodified report of the above results.
- 3 This statement has been prepared in accordance with the Companies (Indian Accounting Standard) Rules. 2015 (Ind AS) prescribed under Section 133 of the Companies Act, 2013 and other recognised accounting practices and policies to the extent applicable.
- 4 The Company is primarily engaged in the business of financing and there are no separate reportable segments identified as per the Ind AS 108 - Segment Reporting.
- The Company has discontinued fresh hire purchase/leasing business. The financial results have been prepared on a going concern basis despite Cumulative losses. The Management is of the view that the Company by realization of the assets will be able to generate enough funds to pay off its entire liabilities. In view of the above the accounts have been prepared on the assumption that the Company will continue as a Going Concern.
- 6 In view of carried forward losses and unabsorbed depreciation no provision for tax has been made.
- 7 The figures of the quarter ended on March 31, 2022 are the balancing figures between audited figures in respect of the full Financial Year and the Limited Review year-to-date published figures for the nine months period ended December 31, 2021.
- 8 Fair value changes in the value of long term investments will be considered in the audited accounts for the year ending March 31, 2023. The effect of the same is not expected to be material.
- 9 Previous year/periods figures have been regrouped / reclassified, whenever necessary.
