दक्षिणी दिल्ली निगम के स्वास्थ्य विभाग के निजीकरण की तैयारी नौकरी की तलाश करने वालों को झटका

दक्षिणी दिल्ली नगर निगम के स्वास्थ्य विभाग के निजीकरण की तैयारी हो रही है। इसके तहत सहायक मलेरिया निरीक्षक (एमएआइ) और सहायक लोक स्वास्थ्य निरीक्षक (एपीएचआइ) के पदों पर कर्मचारियों की नियुक्ति किसी तीसरी कंपनी द्वारा की जाएगी। यानि कर्मचारियों को नियुक्त करने से लेकर वेतन देने का कार्य निजी कंपनी का ही होगा। इस मामले में निगम की कोई जिम्मेदारी नहीं होगी। निगम के स्वास्थ्य विभाग ने इसके



लिए योजना बना ली है। योजना के अनुसार विभाग के पास अनुबंधित कर्मचारियों को नियुक्त करने की वजह से कोर्ट केस का बोझ बढ़ जाता है क्योंकि निगम के अनुबंधित कर्मचारी नियमित करने से लेकर अन्य कर्मचारियों की

दी जाने वाली सेवाओं के लिए कोर्ट में केस डालते हैं। इसकी वजह से निगम के अधिकारियों का भी समय बर्बाद होता है और निगम का कोर्ट के लिए वकीलों की ली जाने वाली सेवा पर भी काफी खर्च आता है। इसलिए विभाग ने इन पदों पर निजी कंपनी के माध्यम से कर्मचारियों की नियुक्ति का प्रस्ताव बनाया है। हालांकि, इस प्रस्ताव को अभी स्थायी समिति से लेकर सदन की मंजूरी दी जानी बाकी है। उल्लेखनीय है कि दक्षिणी दिल्ली नगर निगम में 324 पद

एमएआइ और 60 पद एपीएचआइ के स्वीकृत हैं। स्थायी तौर पर इसमें से 255 एमएआइ और 37 एपीएचआइ के पद रिक्त हैं। इन रिक्त पदों में 115 एमएआइ और 24 एपीएचआइ अनुबंधित तौर पर कार्य कर रहे हैं। अगर निजी कंपनी द्वारा इन कर्मचारियों की नियुक्ति होती है तो वर्तमान अनुबंधित कर्मचारियों की सेवाएं समाप्त कर दी जाएंगी। हालांकि, वह अगर कंपनी के माध्यम से आए तो उन्हें उम्र व अनुभव में छूट दी जाएगी। इसमें 40 वर्ष तक का कर्मचारी कंपनी के

माध्यम से आने के लिए आवेदन कर सकेगा। जबकि सामान्य के लिए यह आयु 27 वर्ष तक होगी। यह कर्मचारियों के खिलाफ है। अगर, कुछ पदों से निजीकरण की शुरुआत हुई तो धीरे-धीरे सभी पदों का निजीकरण हो जाएगा। जानी चाहिए क्योंकि इससे निगम के खर्च भी कम नहीं होंगे और न ही काम। हम देखेंगे कि विभाग ने क्या प्रस्ताव बनाया है। किसी भी कीमत पर कर्मचारियों का अहित नहीं होने देगे। वैसे, प्रस्ताव अभी हमारे पास नहीं आया है।

हिंसा के दौरान कई लोग घर से थौला लेकर निकले थे दुकान लूटने

यमुनापार तीन दिनों से हिंसक भीड़ की आग में झुलस रहा है। आम लोग सलामत रहने के लिए हर मुमकिन कोशिश कर रहे हैं, लेकिन दंगाई उनके घरों व दुकानों को भी बख्शा नहीं रहे हैं। उनके घरों पर पथराव करने के साथ ही वाहनों को आग के हवाले कर रहे हैं। हिंसा से परेशान होकर लोगों ने अपने आशियाने को ऊपर वाले के भरोसे छोड़कर यमुनापार से पलायन करना शुरू कर दिया है। हिंसाप्रस्त क्षेत्रों से मोका लगते ही परिवार के

साथ बाहर जाते हुए लोग देखे गए। मंगलवार दोपहर कबीर नगर में पत्थरबाजी हो रही थी। अद्वैत बल ने मोर्चा संभाला हुआ था, तभी यमुना विहार से कुछ लोग बैग लेकर पुलिस के पास पहुंचे और परिवार सीलमपुर तक पहुंचाने की गुहार लगाई। पुलिस पत्थरबाजों से निपटने में लगी हुई थी। परिवार के सदस्यों के चेहरे पर खोफ साफ देखने को मिल रहा था, महिलाओं ने बच्चों को सीने से लगाया हुआ था। इस बीच एक परिवार ने बातचीत में बताया कि वह ऐसी जगह जा रहे हैं, जहां खुद को सुरक्षित महसूस कर सके, जहां डर और भय का माहौल न हो।

सबसे ज्यादा खौफ में वे लोग हैं, जिनके घर मुख्य मार्गों पर बने हुए हैं। दंगाई उन घरों पर पथराव कर रहे हैं। सड़क पर बने ज्यादातर घरों के शीशे दंगाइयों ने तोड़ दिए हैं। दंगाइयों ने मौजपुर, गांवड़ी, ब्रह्मपुर, नूर-ए-इलाही, करावल नगर रोड और चांद बाग में दिन दहाड़े दुकानों को लूटा। लूटने वालों में बच्चे, महिलाएं, युवा से लेकर बुजुर्ग तक शामिल थे। दुकानें खाली होने के बाद दंगाई उसे आग की हवाले कर रहे थे। दंगाइयों के हाथ में जो आया

वह उन्होंने लूट लिया। लूट का सामान ले जाने के लिए लोग घरों से ही थैले लेकर आए हुए थे। जाफराबाद, भजनपुरा, वेलकम, सीलमपुर, कल्याण, न्यू उस्मानपुर, नूर ए इलाही में बड़ी संख्या में फैक्टियां चलती हैं, दंगों की वजह से फैक्ट्री में काम करने वाले कर्मचारी घरों को चले गए हैं। कर्मचारी बस अड्डों व रेलवे स्टेशन तक पहुंचने के लिए घंटियों में टोकरीं खा रहे थे, क्योंकि मुख्य मार्गों पर पत्थरबाजी हो रही थी। इधर मजदूरों के जाने की वजह से फैक्ट्री स्वामी भी चिंतित हैं।

दिल्ली में हुई हिंसा के बाद हालात धीरे-धीरे सामान्य होते जा रहे हैं। कई इलाकों में लोग रोजाना की तरह कामकाज के लिए घरों से बाहर निकल रहे हैं। दमकल विभाग के 100 दमकल कर्मी सड़क पर उतरकर जगह-जगह हालात का जायजा ले रहे हैं। पुलिस के स्पेशल कमिश्नर ऑफ पुलिस एसएन श्रीवास्तव ने कहा कि जल्द ही मामले में और भी गिरफ्तारियां की जाएगी। दिल्ली के स्पेशल कमिश्नर (कानून एवं व्यवस्था) एसएन श्रीवास्तव ने दिल्ली में हुई हिंसा को लेकर कहा, 'फिलहाल स्थिति धीरे-धीरे सामान्य हो रही है। हम मामले दर्ज कर रहे हैं और कानूनी कार्रवाई कर रहे हैं, जल्द ही हम और भी गिरफ्तारियां करेंगे। मुझे उम्मीद है कि ये सभी चीजें सामान्य स्थिति में



बहाल करने में योगदान देंगी। बता दें कि उत्तर-पूर्वी दिल्ली में तीन दिनों से जारी हिंसा में हेड क्रांटेबल और आईबी के अधिकारी समेत 34 लोगों की मौत हो चुकी है, जबकि हिंसा में लगभग 200 लोगों को चोटें लगी हैं। आगजनी में करोड़ों रुपये की संपत्ति का नुकसान हुआ है। हिंसा के सिलसिले में दिल्ली पुलिस ने 18 एफआईआर दर्ज की हैं और

106 लोगों को गिरफ्तार किया गया है। वहीं जीटीबी अस्पताल के चिकित्सा निदेशक डॉक्टर सुनील कुमार के मुताबिक, जीटीबी में अभी तक 30 लोगों की मौत हो गई है। सोमवार से लेकर अब तक 200 के करीब घायल भर्ती हुए थे, इनमें अधिकांश को छुट्टी दे दी गई है। फिलहाल 53 घायल अस्पताल में भर्ती हैं। इनमें एक की हालत ठीक नहीं है। घायलों में ज्यादातर गन शॉट्स और धारदार हथियारों का शिकार हुए हैं। दिल्ली पुलिस ने हिंसा से संबंधित किसी भी प्रकार की जानकारी और हिंसा प्रभावित इलाकों में लोगों की मदद के लिए दो हेल्पलाइन नंबर भी जारी किए गए हैं। लोग इन दो नंबरों 22829334 और 22829335 पर फोन कर सहायता के लिए मदद मांग सकते हैं।

चारों दोषियों को फांसी देने के लिए रोज कैंडल मार्च निकाल रहे द्वारका के लोग

द्वारका में पिछले दो महीने से रोजाना रात आठ बजे निरभया के दोषियों को फांसी पर लटकाने की मांग को लेकर कैंडल मार्च निकाला जा रहा है। खास बात यह है कि इस मार्च में निरभया के माता-पिता भी रोजाना शामिल होते हैं। निरभया की मां बताती हैं कि लोग अपनी इच्छा से मार्च निकाल रहे हैं। यह उन सभी लोगों की लड़ाई है जो महिला सुरक्षा को लेकर शंका से भरे माहौल में जी रहे हैं। यह लड़ाई उन सभी लड़कियों की लड़ाई है जो घर से नौकरी के लिए, पढ़ाई के लिए, खरीदारी के लिए, अपनों से मिलने के लिए इस उम्मीद के



साथ निकलती हैं कि वे काम पूरा होने पर सुरक्षित अपने घर लौट आएंगी। यह उम्मीद यकीन में तभी तब्दील होगा जब लड़कियों के प्रति नकारात्मक सोच रखने वाले लोगों को एक कठोर संदेश दिया जाएगा। जब तक असामाजिक तत्वों को यह नहीं लगेगा कि उनके कृत्य का अंजाम फांसी हो सकता है, तब तक

उनके मन में डर नहीं होगा। आज बदमाश यह सोचते हैं कि कुछ भी हो वे बच निकलेंगे। उनकी सोच को गलत साबित करने की जरूरत है। बता दें कि निरभया सामूहिक दुष्कर्म और हत्या के मामले में दोषी विनय शर्मा के वकील एपी सिंह ने पटियाला हाउस अदालत में एक अर्जी दायर की है। इसमें कहा गया है कि विनय को सिजोफ्रेनिया (एक तरह का पागलपन) है और उसे इलाज की जरूरत है। अदालत को बताया गया कि विनय के सिर पर गंभीर चोट लगी है और उसके हाथ पर भी प्लास्टर लगा है। तिहाड़ जेल प्रशासन की तरफ से अदालत में कहा गया कि विनय ने रविवार को जेल नंबर 3 के सेल में

अपना सिर फोड़ लिया और उसको मामूली चोट आई थी, जिसका इलाज जेल में ही करा दिया गया है। जबकि विनय के वकील ने अदालत में कहा कि विनय के परिजनों के कहने पर वे उससे मिलने जेल गए थे। जहां देखा कि उसके सिर पर गंभीर चोट लगी है और हाथ भी टूटा हुआ है। वह लोगों को नहीं पहचान रहा है।

यहां तक की उसने उन्हें और मां को भी नहीं पहचाना। अर्जी में कहा गया है कि विनय को एक मनोवैज्ञानिक की जरूरत है और उसे इस्टीमेट ऑफ ह्यूमन बिहेवियर एंड एलाइड साइंस (इहबास) में भर्ती कराया जाए। अतिरिक्त सत्र न्यायाधीश महेन्द्र राणा ने इस अर्जी पर शनिवार तक तिहाड़ जेल प्रशासन से जवाब मांगा है। चारों दोषियों के खिलाफ कोर्ट ने निरभया के दोषी विनय की ओर से उसके वकील एपी सिंह ने चुनाव आयोग में याचिका दाखिल की है। याचिका में विनय को दया याचिका पर दिल्ली सरकार द्वारा खारिज करने की राष्ट्रपति से की गई सिफारिश पर सवाल उठाए गए हैं।
