विभाजन योग्य कर प्राप्तियों में राज्यों की हिस्सेदारी 42 फीसद रखने की सिफारिश

नई दिल्ली, १ फरवरी (भाषा)

15वें वित्त आयोग ने वर्ष 2021-22 से 2025-26 के दौरान राज्यों को केंद्र की विभाजन योग्य कर प्राप्तियों में 42 फीसद हिस्सा दिए जाने की सिफारिश की है।

आयोग की रिपोर्ट में केंद्र और राज्यों, दोनों के लिए और वित्तीय घाटे और ऋण को आने वाले वर्षों में सीमित रखने की राह के बारे में सुझाव दिए हैं और सिफारिश की गई है कि बिजली क्षेत्र में सुधार के आधार पर राज्यों को अतिरिक्त उधार लेने की अनुमित दी जाए।

वित्त आयोग एक संवैधानिक निकाय है, जो केंद्र और राज्यों के वित्तीय संबंधों पर सझाव देता है। वित्त मंत्री निर्मला सीतारमण ने लोकसभा में 15वें वित्त आयोग की रिपोर्ट पेश की।

एक आधिकारिक बयान में कहा गया कि 15वें वित्त आयोग ने कोविड-19 महामारी के दौरान संसाधनों की स्थित को विश्वसनीय और मजबूत रखने की सिफारिश की है और कहा है, 'जैसा कि 2020-21 के लिए हमारी रिपोर्ट में कहा गया है, राज्यों की सीधी हिस्सेदारी को 41 फीसद पर रखा जाए।' आयोग का कहना है कि यह 14वें वेतन आयोग की सिफारिशों में राज्यों का हिस्सा 42 फीसद रखने के ही समान है क्योंकि जम्मू-कश्मीर राज्य को दो केंद्र शासित क्षेत्रों में पुनर्गठित करने से करीब एक फीसद समायोजन की आवश्यकता है।

आयोग की सिफारिशों के मुताबिक केंद्र का राजकोषीय घाटा 2021-22 में छह फीसद, 2022-23 में 5.5 फीसद, 2023-24 में पांच फीसद, 2024-25 में 4.5 फीसद और 2025-26 में चार फीसद होना चाहिए। भारतीय प्रशासनिक सेवा के पूर्व अधिकारी एन के सिंह की अध्यक्षता वाली समिति ने पिछले साल नवंबर में राष्ट्रपति राम नाथ कोविंद को अपनी रिपोर्ट सौंपी थी, जिसका शीर्षक 'कोविड काल में वित्त आयोग' था। रिपोर्ट के मुताबिक पांच साल की अवधि के लिए सकल कर राजस्व 135.2 लाख करोड़ रुपए होने की उम्मीद है। उसमें से विभाजन योग्य कर आय (उपकर और अधिभार, तथा संग्रह की लागत हटाने के बाद) के 103 लाख करोड़ रुपए रहने का अनुमान है।
