Scrutinizers Report on Voting through Remote E-voting for Postal Ballot in terms of Section 108 and Section 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management & Administration) Rules, 2014

Dear Sir,

I, Pranay D. Vaidya, Designated partner of Dipesh Pranay and Co. LLP was appointed as a Scrutinizer to conduct the Postal Ballot through remote e-voting process in a fair and transparent manner. The Company has engaged the services of National Securities Depository Limited ("NSDL") as the agency to provide e-voting facility enabling the members to cast their votes electronically in a secure manner in respect of the Resolution as circulated in the Postal Ballot Notice dated January 10, 2023.
