A public interest litigation (PIL) filed by advocate Vandana Shah in the Bombay High Court has sought the cancellation or postponement of the league. The court will hear the plea on May 6. 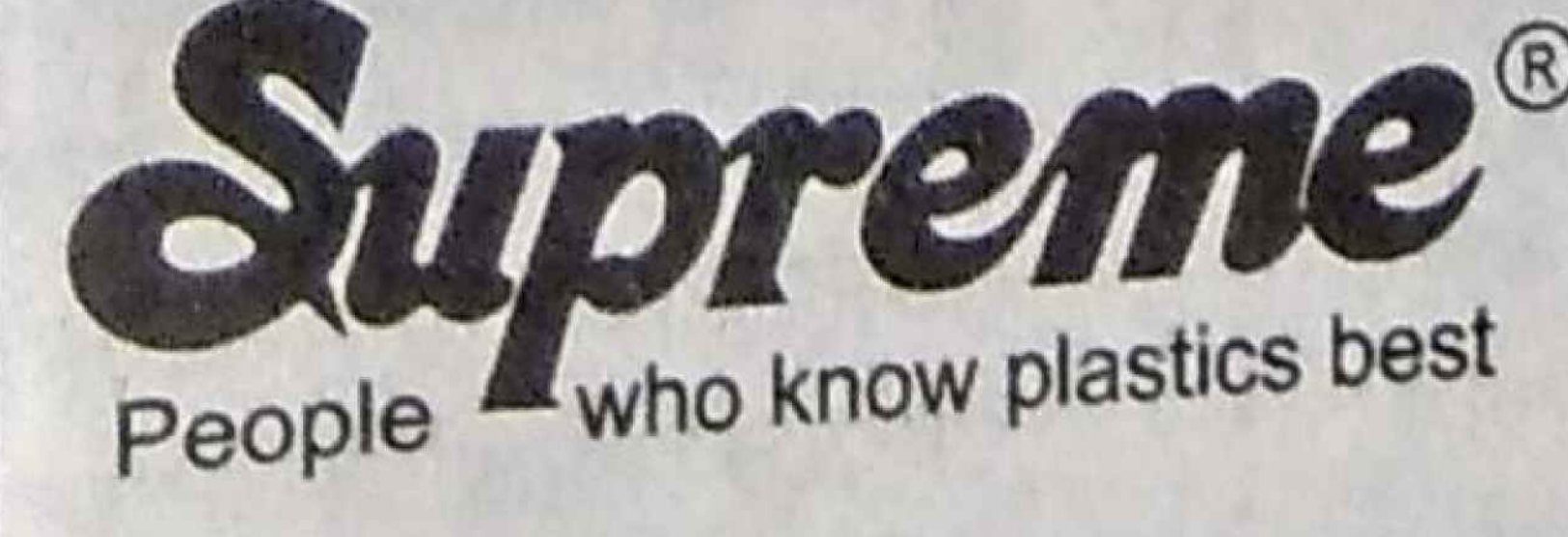
# रुग्ण बरे होण्याचे देशापेक्षा जास्त
