RIL activates Chatbot to assist investors for second and final call of partly paid shares

New Delhi, Reliance Industries Limited (RIL) has re-activated WhatsApp Chatbot to assist investors for the second and final call on its partly paid shares.

The smart WhatsApp chatbot to address investor queries on the Second and Final Call has been activated. The AI-enabled easy-to-use Chatbot is developed by Jio's group company Haptik and was previously used at the time of Rights Issue in May 2020, and the first call in May 2021.

Reliance had made a Rights Issue of 42.26 crore equity shares at Rs 1,257 each. The final call of 50 per cent of the amount - Rs 628.50 per share - has now

become due. November 10, 2021 was the record date to decide holders of the Reliance Partly Paid-up shares, who need to pay the Second and Final Call.

On payment of the Second and Final Call amount, the partly paid-up shares will transition into fully paid-up shares of Reliance Industries, which are traded under symbol RELIANCE on both NSE and BSE.

The Second and Final Call can be paid through following modes: Online ASBA, Physical ASBA, 3-in-1 account, R-WAP facility (enabled for Net-banking, UPI, NEFT and RTGS payments) and payments through Cheque/demand draft.

The payment can be made from November 15 to 29 (both days inclusive).

The credit of the fully paid-up equity shares on payment of the second and final call is expected to take place within two weeks from the last date for payment mentioned in the Final Call Notice i.e. within 2 weeks from November 29, 2021.

Reliance's Rights Issue at a total size of Rs 53,125 crore was the largest ever rights issue in India. This was the world's largest Rights Issue by a non-financial company in the last 10 years.

The existing shareholders of Reliance Industries were offered new shares of the company in 1:15 ratio.

'Predator' prequel 'Prey' to stream in summer 2022

Los Angeles, 'Prey', which is set in the 'Predator' universe with an Indigenous woman as its lead, will stream on Hulu in the US in summer 2022.

In some international markets, it will stream on Disney Plus under the Starbrand, and in Latin America, it will premiere on Star Plus, reports variety.com.

Reports about the existence of a 'Predator' reboot were out there, but its first look, title and the timing of its release were officially announced on Friday as part of its Disney Plus Day promotional event.

'Prey' is produced by Jhane Myers, and is one of a slate of films from 20th Century Studios.

It is directed by Dan Trachtenberg of '10 Cloverfield Lane' fame.

The Indigenous actor Amber Midthunder plays Naru, who according to Disney, wants to "prove her worth as a warrior," and "certainly gets her chance when she comes face to face with the most dangerous hunter of all, the otherworldly predator."

It's not clear whether 'Prey' will be released in theatres.

The 'Predator' franchise began in 1987 with Arnold Schwarzenegger topline the original title. Five more titles in the franchise have been released since then, most recently 2018's 'The Predator' directed by Shane Black.

There were three other 2022 films announced Friday in the Hulu/Star cohort. 'Rosaline', a new take on 'Romeo and Juliet', is from the perspective of the character from the play who is discussed, but never appears: Juliet's cousin Rosaline, with whom Romeo is in love. Kaitlyn Dever stars, and Karen Maine directs.

'The Princess' is an "irreverent action movie set in a fairytale world" and further described as "Sleeping Beauty meets John Wick." Joey King stars, and Le-Van Kiet directs. 'No Exit' stars Havana Rose Liu in what is characterised as a "harrowing suspense-thriller" in which the lead character is "stranded by a blizzard and forced to find shelter at a highway rest area with a group of strangers". It is based on the 2019 novel by Taylor Adams of the same name.
