FRENCH POLLS | National Rally led by 33 per cent of the vote

Le Pen's party takes lead

PARIS

France's National Rally surged into the lead in the first round of legislative elections, according to results released early Monday, bringing the far-right party to the brink of power and dealing a major blow to President Emmanuel Macron's centrists in an election that could set the country, and Europe, on a starkly different course, the AP said in a report.

The results confirmed polling that showed the party with a history of racism and xenophobia and once shunned by the mainstream is no longer taboo, confined to the fringes of French politics. There remains another torrid week of campaigning before the decisive final voting Sunday, and whether the National Rally will be able to win an outright majority and form France's first far-right government since World War II remains uncertain.

Marked by high turnout of nearly 68 per cent that reflected the high stakes, voters handed the Marine Le Pen's National Rally a strong lead, with about 33 per cent of the vote. The number includes the votes from a group of conser-

vative candidates of The Republicans party who had allied with the far-right party in the first round. The New Popular Front, a leftist alliance, finished second with about 28 per cent. The president's centrist group came third with around 20 per cent, according to figures released by the Interior Ministry.

When Macron dissolved the National Assembly on June 9, after a stinging defeat at the hands of the National Rally in French voting for the European Parliament, the deeply unpopular and weakened president gambled that his ri-

vals wouldn't repeat that success when the country's own fate was in the balance.

He and his allies, as well as

politicians on the left, are still hoping they can head off an outright win by the National Rally, and horse-trading began Monday, with some efforts to block far-right candidates tak-

ing shape. The leftist coalition said it would withdraw its candidates in districts where they arrived in third position in order to support other politi-

cians opposed to the far right. Macron's centrist alliance also said some of its candidates would step down before the runoff.

KATHMANDU 'Buddha Boy' gets 10 yr jail

A Nepali court sentenced Ram Bahadur Bamjon, believed by thousands to be a reincarnation of the Buddha, to 10 years in jail for child sexual abuse. Bamjon, known as the "Buddha Boy", gained international attention in 2005 for meditating under a tree for nearly 10 months. The court also ordered Bamjon, 33, to pay \$3,750 in compensation to the victim. His lawyer said he would appeal the verdict in a higher court.

Renowned Albanian novelist Ismail Kadare dies at 88 after being rushed to a hospital in Tirana, his publishing editor said on Monday. A nurse, speaking anonymously, said Kadare suffered a cardiac arrest. Internationally recognised after his 1963 novel "The General of the Dead Army," Kadare gained fame while Albania was under communist rule.
