Subject: Intimation regarding Order of the Hon'ble National Green Tribunal (NGT) under Reg. 30 of SEBI (LODR) Regulation, 2015

Dear Sir/Ma'am,

This is further to our intimation dated 31st August, 2023.

Pursuant to the provisions of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with other related circulars in this behalf, we would like to bring to your kind notice that the Hon'ble NGT has been pleased to pass an Order dated 3rd October, 2023 (uploaded on 4th October, 2023) to the effect that the Consent to Operate granted by Punjab Pollution Control Board (PPCB) for Patiala plant shall remain valid subject to the conditions mentioned in the said Order passed by the Hon'ble NGT.

The details of the matter are as follows: -

i. Name of the authorities: - PPCB/ NGT

ii. Nature and details of the action(s) taken, initiated or order(s) passed: - The Company has deposited environment compensation of Rs. 50 Lakhs and a Bank Guarantee of Rs. 1 Crore in favour of PPCB.

iii. Date of receipt of direction or order, including any ad-interim or interim orders, or any other communication from the authority: - The Order dated 3rd October, 2023 of NGT (uploaded on NGT's website on 4th October, 2023).

iv. Details of the violation(s)/ contravention(s) committed or alleged to be committed: - PPCB vide its communication dated 18th August, 2023 had made certain observations under the Air (Prevention and Control of Pollution) Act and Water (Prevention and Control of Pollution) Act. The remedial action had been completed immediately thereafter.
