The standalone and consolidated results for the quarter ended June 30, 2020, September 30, 2019, half year ended September 30, 2019 and year ended March 31, 2020 has been subject to review / audit by the statutory auditors of the Company.
- In accordance with the approvals received from the Board of Directors on May 21, 2019 and from the shareholders on August 23, 2019, the Company has executed the Business Transfer Agreement on October 1, 2019 and transferred the business of Packaging under the non-automotive products segment of the Company on a going concern basis by way of slump sale to Robert Bosch Packaging Technology India Private Limited. Consequently, profit before tax and profit after tax for the Packaging business has been disclosed separately as discontinued operation under the above results.
- The Company is undergoing major transformation with regard to structural and cyclical changes in automotive market and emerging opportunities in the electro mobility and mobility segment. During the quarter and half year ended September 30, 2020, the Company has made a provision towards various restructuring and transformational projects and disclosed as an exceptional item.
- The spread of COVID -19 pandemic has affected the economic activity across the Globe, including India. Post the lockdown, in line with guidelines prescribed by the Government, the business operations have gradually resumed with adequate precautions. Financial results of the Company had an impact of COVID-19 pandemic and country wide lockdown. Based on the assessment by the Company, it does not anticipate any major challenge in meeting its financial obligations, on long term basis and does not carry any risk in the recoverability and carrying values of its assets including property, plant and equipment, trade receivables, inventories and investments and does not anticipate any additional liability as at September 30, 2020. The Company will continue to closely monitor any material changes to the future economic conditions and its consequent impact on its business.

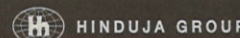
