Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that a fire incident occurred this afternoon at Building No. 2, Plot No. 11-18, Shree Laxmi Co-op. Industrial Estate Ltd., Hatkanangle, Dist. Kolhapur, which is owned by the Black Rose Industries Limited (“the Company”).

We would like to clarify that the Company was not carrying out any of its operation at the affected site and therefore, there is no impact on the business operations or functions of the Company.

The loss is only related to the value of the building.

The asset impacted by the fire is fully insured, and the Company has already taken the necessary steps to file an insurance claim to cover the loss and damage caused by the incident.
