Responsibility of the Management The Management of the company is responsible to ensure compliance with the requirements of the Companies Act 2013 and the Rules made thereunder in relation to exercising of voting rights through electronic means, on the resolution(s) as set out in the Notice convening the 33rd Annual General Meeting dated 14th August 2024

Responsibility as a Scrutinizer My responsibility as a Scrutinizer for the e-voting process at the 33rd Annual General Meeting is restricted to the preparation of a Scrutinizer's Report on the votes cast "in favour" or "against" the resolutions as set out in Item Nos, from 1 to 6 in the Notice convening the 33rd Annual General Meeting of the company dated 14th August 2024, based on the reports generated from the e-voting system provided by M/s Central Depository Services (India) Limited (CDSL), the authorized agency, engaged by the company for providing e-voting facilities.

- The E-voting period remained open from 9.00 a.m. on Sunday 22nd September 2024 upto 5.00 p.m. on Tuesday 24th September 2024. Further the Remote Evoting period was completed on the date preceding the date of Annual General Meeting.
- The Company has appointed Central Depository Services Limited (CDSL) as service provider for extending the facility to the electronic voting to the shareholders of the company. Link Intime India Private Ltd. / Consultants is the Registrar and Share Transfer Agent of the company.
- At the Annual General Meeting, the Company facilitated the members present in meeting through VC/OAVM facility and have not cast their votes through Remote E-voting facility to cast their vote through E-voting facility provided during the Annual General Meeting in compliance with the provisions of Rule 20 (a) (viii) of the Companies (Management and Administration) Rules 2014, as amended from time to time.
- On completion of the E-Voting, in compliance of the provisions of Rule 20 (4) (viii) and
