Spike in households taking up NREGS work

Poor monsoon one of reasons behind spurt in June demand

HARIKISHAN SHARMA New Delhi, July 16

RECORDING A SHARP increase in the demand for work under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS), the monthly figure of households availing jobs under the programme touched 30.4 million in June this year, the highest in the last three years.

recorded in June, 2020, during the first wave of Covid-19, when 38.9 million families had availed the MG-NREGS, in the wake of migrants returning to their village after national lockdown.

Of the 30.3 million families in June 2023, Tamil Nadu had the highest share of 5.18 million families followed by Andhra Pradesh 3.31 million, Rajasthan 3.26 million lakh, Uttar Pradesh 3.21 million, and Bihar 2.23 million.

million families for the month of June, 2023 includes only 962 families from West Bengal—the state where work under MGNREGS has been halted following suspension of funds from the Centre.
