It has two manufacturing facilities in Gujarat and one in Telangana, with a total capacity of more than 13,000 MTPA, which the company is further enhancing to 20,000 MTPA. Sigachi has a global sales and distribution network exporting to more than 40 countries across Asia, Australia, American Continent, Europe and Middle East and around 70% revenues coming from exports.

Sigachi also has plans to diversify its product mix and has recently announced entry into B2C branded generic OTC products as well as catering to B2B nutraceutical product manufacturing.

The company has had a strong growth track record with a 3 year CAGR of 25% growth in Revenues, 27% in EBITDA and 28% in PAT. The company is debt free as of FY22 end.
