# Brief proceedings of the 25th Annual General Meeting

The 25<sup>th</sup> Annual General Meeting (AGM) of the Members of Rossell India Limited was convened and held on Friday, 9<sup>th</sup> August, 2019 at Kala Kunj, 48, Shakespeare Sarani, Kolkata 700 017 the Meting was commenced at 10:30 A.M. and concluded at 12:00 Noon.

- Mr. H. M. Gupta, Executive Chairman, Chaired the Meeting. A total of 169 Members were present at the Meeting in Person and 2 Members was present by proxy and 3 Members were present as corporate representative. Hence the quorum being present, the Chairman declared the AGM open. The Notice convening the 25<sup>th</sup> AGM and other documents as received by the Members well in time were taken as read with the permission of the Members present.
- Thereafter, the Chairman delivered his speech highlighting, inter-alia, the industry scenario, current performance of the Company and future prospects of the various business segments of the Company.
- Since there was no qualification or adverse remark, the Auditor's Report was taken as read pursuant to section 145 of the Companies Act, 2013.

- 4. Appointment of Mr. Ajai Shukla (DIN-06459352) as an Independent Director of the Company, with effect from 1<sup>th</sup> April, 2019 for a tenure of one year.
- 5. Ratification of the remuneration payable to M/s. Shome & Banerjee, Cost Accountants as Cost Auditors for the financial year 2019-2020.
