Pursuant to regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 this is to inform that in view of the outbreak of COVID-19 in India and in view of the lockdown announced by Central Government, the manufacturing and dyeing operations of the company located at Nambiyur and Perundurai were remained shut from March 24, 2020 due to lockdown.

The Company's registered office premises were closed on March 24, 2020. The company and manufacturing operations has been partially re- opened w.e.f. May 6, 2020. Some of the Company's production pending orders are on hold as per requirements of buyers. However, upon opening of office, we are in process of execution of pending transactions.

Keeping in view, our priority of health and safety of staff of the Company, We have opened our Offices and production units with reduced staff and restricted timings as per the guidelines of Authorities.

The Company is taking utmost care of its staff and work force like sanitization, social distancing, mandatory mask wearing, and thermal check at the gate, maintaining proper hygiene.

In view of lock down, the profitability and sales during 1st quarter (April to June) is likely to be adversely impacted and may deferred to subsequent quarters. However, Company estimates to meet the breakeven level. As the
