2. The e-voting facility both for e-voting prior to the AGM (remote e-voting) and voting at the AGM by electronics means (e-voting) was provided by Central Depository Services (India) Limited (CDSL).
3. As per the information provided by the Company the Notice of the 28th Annual General Meeting was sent to the shareholders on September 06, 2023 and subsequently the said Notice was also placed on the website of the Company at [www.dhatre.com](http://www.dhatre.com)

4. Pre advertisement published on September 05, 2023 and post advertisement published on September 07, 2023 pursuant to Rule 20(4)(v) of the Companies (Management and Administration) Rules, 2014 (Amendment Rules 2015),  
the remote e-voting opened at 9:00 AM on September 25, 2023 (Monday) and remained open up to 5:00 PM on September 28, 2023 (Thursday).
5. After declaration of voting by the Chairman, the shareholders present at the AGM through VC voted through e-voting facility provided by CDSL at the AGM.
6. The Shareholders holding shares as on September 22, 2023, "cut off date", were entitled to vote on the resolutions stated in the Notice of the 28th Annual General Meeting of the Company.
7. As per the information given by the Company the names of the shareholders who had voted by remote e-voting through the facility provided by CDSL had been blocked and only those members who were present at the AGM through VC and who had not voted on remote e-voting were allowed to cast their votes through e-voting system during the AGM.




