Please note that on Saturday, December 23, 2023 at 5.30 p.m., the Company has received an Order from the Joint Commissioner CGST & Central Excise, Bhopal, Madhya Pradesh raising a GST demand of ₹ 56,602,264/- and levying penalty of ₹ 5,660,226/-. The Company will be filing an appeal against the said Order.
