**SUMMARY OF THE PROCEEDINGS OF THE RESOLUTIONS PASSED**  
**BY WAY OF POSTAL BALLOT**

The Board of Directors, at its meeting dated 11<sup>th</sup> May, 2022, decided to obtain consent of the members through Postal Ballot pursuant to provisions of Section 110 of the Companies Act, 2013 (the "Act"), read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 and in compliance with the General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No.22/2020 dated June 15, 2020, General Circular No.33/2020 dated September 28, 2020, General Circular No. 39/2020 dated December 31, 2020, General Circular No. 10/2021 dated June 23, 2021 and General Circular No. 20/2021 dated December 8, 2021 issued by the Ministry of Corporate Affairs ("MCA") (hereinafter collectively referred to as "MCA Circulars"), Secretarial Standard on General Meetings (SS 2) and Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and pursuant to other applicable laws and regulations (including any statutory modification or re-enactment thereof for the time being in force, and as amended from time to time), via Postal Ballot only through remote e-voting for the following:

1. Re-appointment of Sri Devesh Bansal as Whole-Time Director of the Company
2. Re-appointment of Sri Siddharth Bansal as Whole-Time Director of the Company
3. Appointment of Sri Raj Kumar Patodi as an Independent Director of the Company

The Postal Ballot Notice dated 11<sup>th</sup> May, 2022 was sent to the members of the Company whose names appeared in the Register of Members/ List of Beneficial Owners as received from National Securities Depositories Limited ("NSDL") and Central Depository Services Limited ("CDSL") on Friday, 13<sup>th</sup> May, 2022 (Benpos Date).

The Company had completed sending the Postal Ballot Notice by way of e-mail on 16<sup>th</sup> May, 2022. In compliance with the provisions of Section 108 and 110 of the Act read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the Listing Regulations, the MCA Circulars and Secretarial Standards 2 on General Meetings, the Company had provided e-voting facility only for its Members to enable them to cast their votes electronically through National Securities Depository Limited ("NSDL"). The e-voting commenced on Wednesday, 18<sup>th</sup> May, 2022 at 9:00 AM IST and ended on Thursday, 16<sup>th</sup> June, 2022 at 5:00 PM IST.

The said notice has also been placed on the website of the Company. The intimation about completion of dispatch of the Postal Ballot Notice and the last date for receipt of reply from shareholders was also intimated to the members by way of publication of advertisement in the newspapers namely, Financial Express (English Language) and Ek Din (Bengali Language) on 17<sup>th</sup> May, 2022.
