**Sub:** Intimation of temporary suspension of operations as a precautionary measure to avoid disruption due to "Punjab Morcha" announced by Bhartiya Kisan Union (Ekta-Ugrahan)

Dear Sir / Madam,

This is in reference to 'Punjab Morcha' announced by Bhartiya Kisan Union (Ekta- Ugrahan) from July 21, 2022 to July 25, 2022.

As a precautionary measure to avoid any confrontation / untoward incidents and to ensure the safety & security of our workforce as well as protection of our assets, the Management of Company has decided proactively to temporarily close / lock down / suspend its major operations in Punjab from intervening night of 20th – 21st July, 2022.

The Company shall manage to run few continuous process units to sustain environment, for which our captive power generation & power transmission units and services shall operate. We shall also deploy our limited security inside the premises to avoid any untoward incident.

We shall review to start of operations after withdrawal / end of dharna after consultation with Government of Punjab.

The disclosures as prescribed under SEBI Circular no CIR/CFD/CMD/4/2015 dated September 9, 2015 is annexed as Annexure-I.
