Sub: Acquisition of KPS3 Transmission Limited (KPS3TL) by POWERGRID under TCB route.

Dear Sir,

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is informed that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff based competitive bidding, has on 21.03.2023 acquired “KPS3 Transmission Limited” (KPS3TL), the Project SPV to establish “Establishment of Khavda Pooling Station-3 (KPS3) in Khavda RE Park”, on build, own, operate and transfer (BOOT) basis from the Bid Process Coordinator - REC Power Development and Consultancy Limited.

The Transmission system comprises of establishment of a new 765/400kV GIS, 765kV D/c Transmission Line and associated work in the State of Gujarat. The transmission system is an Inter State Transmission System Project and is to be completed in 21 months.

Brief details of any governmental or regulatory approvals required for the acquisition;	KPS3TL was incorporated on 29/04/2022 by the Bid Process Coordinator as per the "Guidelines Encouraging Competition in Development of Transmission Projects" and "Tariff based Competitive-bidding Guidelines for Transmission Service" notified by Ministry of Power (MoP). Requisite approvals were obtained by the Bid Process Coordinator for transfer of KPS3TL. Approval for Grant of Transmission License and Adoption of Transmission charges are to be obtained from Central Electricity Regulatory Commission by KPS3TL after the acquisition by POWERGRID.
6.	Indicative time period for completion of the acquisition;	The entity was acquired as per the time lines furnished by Bid Process Coordinator.
7.	Cost of acquisition or the price at which the shares are acquired;	The entity was acquired with a net payment of about Rs. 11.29 Cr. and the acquisition includes 50,000 equity shares at par at Rs. 10 each as on the acquisition Date (21.03.2023). However, the acquisition price is subject to adjustment as per the audited accounts of the Company as on the acquisition Date.
8.	Nature of consideration - whether cash consideration or share swap and details of the same;	Cash Consideration as detailed at S. No. 7 above.
9.	Percentage of shareholding / control acquired and / or number of shares acquired;	100%
10.	Brief background about the entity acquired in terms of products/line of business acquired, date of incorporation, history of last 3 years turnover, country in which the acquired entity has presence and any other significant information (in brief).	The entity shall be engaged in the business of transmission of Power. The entity was incorporated on 29/04/2022 by Bid Process Coordinator. The entity is yet to start commercial operation, as such no turnover has been recorded since its incorporation. The entity will be operating in India.
