Amazon faces UK class-action suit over 'secretive' algorithm

Amazon.com Inc. is facing a UK class-action lawsuit over claims that it uses a "secretive" algorithm to abuse its dominant position in the online marketplace. Amazon has made millions of customers pay more by hiding better deals to boost its own products. However, the law firm behind the case alleges. Meanwhile, Amazon has said the claim "is without merit and we're confident that it will be dismissed through the legal process."

Novartis allows seven nations to produce generic leukemia drug



Novartis AG agreed to allow generic drugmakers in seven middle-income nations to produce a leukemia treatment, the first time a voluntary license has been granted for a patented cancer drug as part of a patent pool initiative. The deal brings the drug, used to treat chronic myeloid leukemia and may be made in Egypt, Guatemala, Indonesia, Morocco, Pakistan, the Philippines and Tunisia, according to the Medicines Patent Pool, a UN-backed organization.

Blackstone's profit falters as rising rates chill dealmaking

Blackstone's third-quarter profit faltered as wild markets and rising borrowing costs chilled the pace of dealmaking at the world's largest alternative-asset manager. Distributable earnings in the quarter fell 8% to \$1.37 billion, Blackstone reported on Thursday. That measure of earnings available to shareholders amounted to \$1.06 a share, beating analyst expectations of \$0.97 a share.

Global nuclear summit drops Russian regulator, executives

Russia came under pressure at IAEA after seizing Europe's biggest N-power plant in Ukraine

Russia lost its place on stage at a key international nuclear summit in Washington next week, as US and allies seek ways to limit the influence of Kremlin-controlled atomic fuel and technology suppliers on the global market.

The International Atomic Energy Agency confirmed Thursday that executives from Rosatom Corp. and Russia's industry regulator were dropped from the agenda of next week's meetings in the US capital. White House officials have been considering for months ways to reduce the Kremlin's influence on global nuclear markets, with Rosatom continuing to be the biggest exporter of nuclear fuel and reactors.

Russia has come under increased pressure at the IAEA for endangering nuclear security following the seizure of Europe's biggest atomic-power plant early in its war against Ukraine. The Zaporizhzhia station, which reactors designed to generate a fifth of Ukraine's electricity, has subsequently been targeted by artillery and missiles, threatening to provoke a radiological accident.

change because of programmatic or personal reasons," the IAEA said in a statement. "We are confident that the current program will ensure a successful conference" that will include discussions around "the role of nuclear power and its contribution to energy security."

VW sued for its climate lobbying activities

Volkswagen AG was sued by institutional investors in Germany concerned that despite making public commitments to fighting climate change, the carmaker may be privately lobbying against its environmental ambitions.

A group of Swedish public pension funds, Danish Academic Pension and the Church of England Pensions Board filed the suit at a German court seeking to make VW include an item about their lobbying activities to the agenda of its shareholder meeting.

If successful, the action would alter VW's charter to allow the disclosure. ClientEarth, environmental lawyers supporting the case, said in a statement.

The investors "are concerned that while the auto giant is publicly championing the green transition it may be undertaking lobbying activities that run counter to its stated climate ambitions," ClientEarth said. "This potential contradiction exposes the company to reputational and operational damage and puts the security of their investments in question."
