 उपरोक्त विवरण, सेबी (सूचीकरण दायित्व और प्रकटीकरण आवश्यकताएँ) विनियमावली 2015 के विनियमन 33 के अंतर्गत स्टॉक एक्सबेंज के पास फाइलबद्ध त्रैमासिक लेखापरीक्षित वित्तीय परिणामों के विस्तृत प्रारूप का एक सारांश है। त्रैमासिक अवधि में समाप्त लेखापरीक्षित वित्तीय परिणामों का पूर्ण प्रारूप, स्टॉक एक्सबेंज की वेबसाइट अर्थात् www.bseindia.com पर तथा कंपनी की वेबसाइट www.dionglobal.com पर भी उपलब्ध है। मैसर्स डायोन ग्लोबल सॉल्यूशन्स लिमिटेड के विरुद्ध ऋणशोधनाक्षमता एवं दिवालिया (न्याय निर्णयन प्राधिकरण के लिए आवेदन) नियमावली 2016 के नियम ६ के साथ पठित ऋणशोधनाक्षमता एवं दिवालिया संहिता 2016 की धारा 9 के अंतर्गत कॉर्पोरेट ऋणशोधनाक्षमता समाधान प्रक्रिया (सीआईआरपी) आरंभ करने की एक विनती के साथ एक आवेदन माननीय एनसीएलटी दिल्ली के समक्ष प्रस्तुत किया गया था। कॉर्पोरेट ऋणशोधनाक्षमता समाधान प्रक्रिया (सीआईआरपी) आरंभ करने के उक्त आवेदन को माननीय राष्ट्रीय कंपनी कानून न्यायाधिकरण (एनसीएलटी), नई दिल्ली पीठ (माननीय एनसीएलटी / माननीय निर्णायक प्राधिकरण) ने अपने आदेश दिनांक 18.08.2020 द्वारा स्वीकार कर लिया है। आईबीसी कार्यवाहियों के अंतर्गत, बोर्ड की शक्ति 18.08.2020 से निलंबित कर दी गई थी। एनसीएलटी के आदेश में 18.08.2020 से कॉर्पोरेट ऋणशोधनाक्षमता समाधान प्रक्रिया (सीआईआरपी) के पूरा होने तक या धारा 31(1) के अंतर्गत समाधान योजना को अनुमोदित किये जाने या धारा 33 के अंतर्गत कंपनी के परिसमापन के लिए एक आदेश पारित करने तक, जो भी पहले हो, एक स्थगन का भी प्रावधान किया गया है। वर्तमान में, कंपनी के संबंध में सीआईआरपी प्रक्रिया जारी है। ऋणशोधनाक्षमता संहिता की धारा 20 के अनुसार, कंपनी का प्रबंधन एवं परिचालन, अंतरिम समाधान व्यवसायी

(आईआरपी) / समाधान व्यवसायी (आरपी) द्वारा किया जा रहा है। कंपनी के सभी कार्यकारी निदेशकों, सीएफओ और कंपनी सचिव ने सीआईआरपी आरंभ होने से पूर्व कंपनी से त्यागपत्र दे दिया था। इन संबंधित पदाधिकारियों की अनुपरिधाति में, जो बड़ी समापन प्रक्रिया एवं विशीय रिपोर्टिंग के लिए प्राथमिक रूप में उत्तरदायी हैं, समाधान व्यवसायी ने कंपनी के वर्तमान कर्मचारियों और नियुक्त सलाहकारों के माध्यम से इन वित्तीय विवरणों को तैयार करवाया है। कंपनी के निदेशक मंडल की उन शक्तियों का प्रयोग करते हुये समाधान व्यवसायी द्वारा इन वित्तीय विवरणों को रिकॉर्ड पर लिया गया है, जो उन्हें संहिता की धारा 17 के प्रावधानों के अनुसार

प्रदान की गई हैं। समाधान व्यवसायी ने संहिता के अंतर्गत नियत अपने कर्तव्य के अनुपालन एवं निर्वहन के उद्देश्य से इन वित्तीय विवरणों को पूर्ण विश्वास के साथ रिकॉर्ड पर लिया है। सेबी (एलओडीआर) 2015 के विनियम 33(3)(डी) के अनुसार, यदि सूचीबद्ध इकाई की सहायक कंपनियां है, तो इसे वार्षिक लेखापरीक्षित एकल वितीय परिणाम प्रस्तुत करते समय, लेखापरीक्षण रिपोर्ट के साथ वार्षिक लेखापरीक्षित समेकित वित्तीय परिणाम भी प्रस्तुत करना होगा। यह ध्यान दिया जाना चाहिये कि समाधान व्यवसायी के पास अपनी शक्तियों के अंतर्गत केवल कॉप्पेरेट देनदार के प्रबंधन पर नियंत्रण की शक्ति होगी, ना कि इसकी सहायक

कंपनी, सहयोगी या किसी अन्य समुहगत कंपनियाँ पर। अतः स्टॉक एक्सचेंज में केवल एकल लेखापरीक्षित वित्तीय परिणाम ही प्रस्तुत किये जाते हैं। सेबी (सूचीकरण दायित्व एवं प्रकटीकरण आवश्यकताएँ) विनियमावली 2015 के विनियम 33(2)(बी) के अनुसार, स्टॉक एक्सचेंज के पास प्रस्तुत किसी कंपनी के वित्तीय परिणामों पर अध्यक्ष अथवा प्रबंध निदेशक अथवा पूर्णकालिक निदेशक अथवा इन सभी की अनुपस्थित में, कंपनी के किसी भी ऐसे निदेशक द्वारा हस्ताक्षर किये जायेंगे जिन्हें वितीय परिणामों पर हस्ताक्षर करने के लिए निदेशक मंडल द्वारा पूर्णरूपेण ढंग से प्राधिकृत किया गया हों। दिनांक 18 अगस्त 2020 से आरंभ हुई जारी कॉर्पोरेट ऋणशोधनाक्षमता समाधान प्रक्रिया के दृष्टिगत, निदेशक मंडल की शक्तियों को निलंबित कर दिया गया है और ये शक्तियां अब माननीय एनसीएलटी, नई दिल्ली द्वारा 18.08.2020 को पारित आदेश के अंतर्गत कंपनी के समाधान व्यवसायी के पास निहित हैं। तदनुसार, 31 दिसंबर 2023 को समाप्त तिमाही के कंपनी के उपरोक्त वितीय परिणामों को रिकॉर्ड पर लिया गया था तथा समाधान

व्यवसायी द्वारा संबंधित पदाधिकारियों को निर्गत करने के लिए प्राधिकृत किया गया। कॉर्पोरेट ऋणशोधनाक्षमता समाधान प्रक्रिया के दौरान प्राप्त एक समाधान योजना को ऋणदाताओं की समिति द्वारा अनुमोदित किया गया है और इसे

माननीय एनसीएलटी के पास प्रस्तुत किया गया है। अंतिम अनुमोदन के लिए प्रकरण अभी भी माननीय एनसीएलटी के पास लंबित है। चुंकि कंपनी सॉफ्टवेयर उत्पाद एवं सेवाओं के व्यवसाय में है, इसीलिए लाइसेंस शुल्क राजरव तिमाही प्रति तिमाही भिन्न-भिन्न हो सकता है।

कंपनी मुख्यतः सॉफ्टवेयर उत्पाद एवं सेवाओं के व्यवसाय में कार्यव्यस्त है, जिसे प्रबंधन की राय में कंपनी अधिनियम 2013 की धारा 133 के अंतर्गत निर्धारित 'परिचालनगत खण्डवारों' पर आईएनडी एएस 108 के अनुसार एकमात्र रिपोर्ट करने योग्य व्यवसाय खंडवार माना जाता है।
