In terms of Regulation 30 and other applicable provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and subsequent to our previous intimation on the above captioned subject vide dated 01st September 2021, we would like to inform you that the company has resumed its operation at the company's plant located in Vill : Dhudhua, Tehsil : Jandaha, Dist:Vaishali, Bihar which was temporarily disrupted owing to flooding and water logging at the factory premises caused by heavy rains since 15th August 2021.
