**PROCEEDINGS FOR THE 34TH ANNUAL GENERAL MEETING OF CRESSANDA SOLUTIONS LIMITED HELD ON MONDAY THE 30TH SEPTEMBER, 2019 AT 12.00 NOON AT SANA COMMUNITY HALL 9/10/11, PWD SHED, RCB MARG, OPP NOOR BAUG HALL, MUMBAI-400009.**

As per the Notice dated 12<sup>th</sup> August, 2019, the 34th Annual General Meeting (AGM) of the Company was held on 30th September, 2019 at 12.00 Noon at Sana Community Hall, 9/10/11, PWD Shed, RCB Marg, Opp Noor Baug Hall, Mumbai-400009.

Mr. Ramesh Laximan Bhosle - Chairman of the Company presided over the proceedings and welcomed the members to the 34<sup>th</sup> Annual General Meeting of the Company.

The Chairman introduced the Board Members present on the dais to the Members of the Company.

The Chairman acknowledged the attendance of Mr. Shrikrishna Baburam Pandey - Non-Executive Director & Independent Director, Mr. Manendra Singh- Non-Executive & Independent Director, Ms. Bandana Singh - Independent Non- Executive Director, Mr. Kishan Lal Sanganeria - Independent Director and M/S Tariq Budgujar & Co. - the Secretarial Auditors, The Statutory Auditor of the Company, M/s. C. P. Jaria & Co, Chartered Accountants.

18 members being were present in person or through proxy in the meeting. Chairman declared the meeting as validly convened as per terms of Section 103 of Companies Act, 2013 and as per Articles of Association of Company.

The Chairman then addressed the members and gave an overview of the financial performance of the Company for the financial year ended 31<sup>st</sup> March, 2019 and its future outlook.

The Chairman then took up the formal proceedings of the meeting. With the concurrence of the members the Notice of 34<sup>th</sup> Annual General Meeting together with the Financial Statements and Director's Report were taken as read.

The Chairman then requested the Director, Mr. Shrikrishna Baburam Pandey, to read the Auditor's Report and with the permission of the members it was taken as read.

The Chairman then took up the items of Ordinary Business and Special Business before the AGM, as listed under Sr. Nos. 1 to 4.

The Chairman then informed the members that in accordance with the provision of Companies Act, 2013, read with the rules made there under and SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 with the Stock Exchange, the Company had extended the remote e-voting facility through Central Depository Services Limited (CDSL) to enable the members to cast/exercise their vote(s) electronically on the agenda items specified in the Notice of 34<sup>th</sup> AGM. The company was not able to offer remote e-voting process.

The scrutinizer demonstrated the empty ballot boxes to the members and locked and sealed it in the presence of the members of the Company.


