Sub. : Notification issued by the Ministry of Electronics and Information Technology

Dear Sir / Madam,

This is to inform that the Ministry of Electronics and Information Technology has vide its Notification dated February 01, 2024, published in the Official Gazette of India on February 02, 2024 ("Notification"), interalia declared the computer resources relating to the Mutual Fund System and its Database, being Critical Information Infrastructure ("CII") of the Company, and the computer resources of their associated dependencies, to be protected systems for the purposes of the Information Technology Act, 2000 ("IT Act").

As per the IT Act, as amended, CII means Computer Resource, the incapacitation or destruction of which, shall have debilitating impact on National Security, Economy, Public Health or Safety. Further, National Critical Information Infrastructure Protection Centre ("NCIIPC"), an organization under the National Technical Research Organization ("NTRO"), has been notified as the national nodal agency in respect of CII Protection.

As per the guidelines for identification of CII issued by NCIIPC, identification and assessment of CII is based on the criticality of the functions and services provided by the entity and the magnitude of impact on National Security, National Economy, Public Health or Public Safety in case of incapacitation / destruction of its Information and Communication Technology ("ICT") infrastructure based on Impact on Customers, Business and Government functions, Timeframe after which the impact level of non-availability of the ICT infrastructure will be very significant, Geographical or Environmental impact, if any, of incapacitation / destruction, level of dependency.

The guidelines for protection of CII, and the rules for the Information Security Practices and Procedures for Protected System are prescribed by the Central Government, from time to time.

A copy of the Notification is enclosed for reference.

The Company is in the process of initiating steps to update its name from KFin Technologies Private Limited to KFin Technologies Limited, in the Notification.

का.आ. 421(अ).—केंद्रीय सरकार, सूचना प्रौद्योगिकी अधिनियम, 2000 (2000 का21) की धारा 70 की उपधारा (1) और उप-धारा (2) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, केफिन टेक्नोलॉजीज प्राइवेट लिमिटेड की नाजुक सूचना अवसंरचना होने के कारण म्युचुअल फंड प्रणाली और उसका डेटाबेस से संबंधित कंप्यूटर संसाधनों एवं उनसे सहयुक्त आश्रितताओं के कंप्यूटर संसाधनों को उक्त अधिनियम के प्रयोजनों के लिए एतद्वारा संरक्षित प्रणाली घोषित करती है और निम्नलिखित व्यक्तियों को संरक्षित प्रणालियों तक पहुंच बनाने के लिए प्राधिकृत करती है, अर्थात्:-

- (ख) संविदात्मक प्रबंधित सेवा-प्रदाता या तृतीय पक्षकार विक्रेता के दल का कोई सदस्य जिसे आवश्यकता के आधार पर पहुंच बनाने के लिए केफिन टेक्नोलॉजीज प्राइवेट लिमिटेड द्वारा लिखित रूप में प्राधिकृत किया गया है:और
- (ग) मामला दर मामला के आधार पर, केफिन टेक्नोलॉजीज प्राइवेट लिमिटेड द्वारा लिखित रूप में प्राधिकृत कोई परामर्शी, विनियामक, सरकारी पदाधिकारी, संपरीक्षक और पणधारी।

- **S.O. 421(E)**.—In exercise of the powers conferred by sub-sections (1) and (2) of section 70 of the Information Technology Act, 2000 (21 of 2000), the Central Government hereby declares the computer resources relating to the Mutual Fund System and its Database, being Critical Information Infrastructure of the KFin Technologies Private Limited, and the computer resources of their associated dependencies, to be protected systems for the purposes of the said Act and authorises the following persons to access the protected systems, namely:—
 - (a) any designated employee of the KFin Technologies Private Limited authorised in writing by the KFin Technologies Private Limited to access the protected system;
 - (b) any team member of contractual managed service provider or third-party vendor who have been authorised in writing by the KFin Technologies Private Limited for need-based access; and
 - (c) any consultant, regulator, Government official, auditor and stakeholder authorised in writing by the KFin Technologies Private Limited on case to case basis.
- 2. This notification shall come into force on the date of its publication in the Official Gazette.
