We would like to bring to your attention that Mr. Rajendra Mahavirprasad Ruia was appointed as Additional Director under the category of Non-Executive Independent Director of the Company in Board Meeting of the Company held on 12th August , 2024 and this appointment was subject to approval of shareholders in the 30th AGM of the Company held on 17th September, 2024. Since, he had been appointed as an Additional Director, therefore we had not given this disclosure within time of conclusion of the Board Meeting as we were of the view that this appointment was subject to approval of shareholders.

We also state that the fact of appointment of this Director in Board Meeting has also been mentioned in the AGM Notice and Annual Report of the Company and hence there was no intention of any non-compliance. But now we realised that this disclosure should also have
