Pursuant to Regulation 30 of SEBI Listing Regulations, we would like to inform that BSE Limited has, vide their mail dated June 28, 2024, imposed a fine of Rs. 5000/- on the Company under Regulation 33 of the SEBI Listing Regulations for delay in submission of financial results within the prescribed period.

The Company's Board Meeting for approval of financial results was held within the prescribed time limit and also the results were uploaded on Stock Exchange. However, the Meeting was concluded at 11:25 P.M., so the results were to be uploaded within 30 minutes, i.e. by 11:55 P.M. But the Company has uploaded Financial Results on Company's BSE Portal within 41 minutes, i.e., at 12:06 A.M. due to OTP not generated within stipulated time at the time of submitting Financial Results on Company's BSE Portal. Due to this Stock Exchange has levied penalty. The company's representation was not accepted by Stock Exchange and hence the company would be paying the said penalty.

The details as required under SEBI Listing Regulations read with Circular no. SEBI/HO/CFD/CFD-PoD-1/P-CIR//2023/123 dated July 13, 2023 are enclosed as Annexure I.
