**Sub: Intimation of waiver application for delay in compliance with Regulation 60(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

The Company being debt listed on BSE Limited, has received an email dated October 30, 2023 from BSE Limited concerning delay in compliance with Regulation 60 (2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 viz. intimation of record date for interest payment during the quarter ended September 30, 2023 and has imposed a one time penalty of INR 10,000/- plus applicable taxes.

In response to the aforesaid notice, the Company vide email dated October 31, 2023 formally requested BSE Limited to grant waiver of the imposed fine w.r.t. non-compliance of Regulation 60 (2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. It is important to highlight that the Company had already informed the record date for interest payment during the quarter ended September 30, 2023 vide intimation dated June 26, 2023 and the same was reiterated vide intimation dated September 06, 2023 on Debt segment of BSE Limited. The intimation made on September 06, 2023 merely represents a deliberate reiteration of information previously conveyed to our stakeholders vide letter dated June 26, 2023.

Pursuant to applicable regulations of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the details pertaining to aforesaid action is enclosed as Annexure I to this intimation.
