## Execution of agreement in relation to sale of all the shares held by the Company in Tern Distilleries Private Limited.

United Spirits Limited ("Company"/ "USL") has entered into a definitive agreement for sale of its entire shareholding in its wholly owned subsidiary Tern Distilleries Private Limited ("Tern Distilleries"), to Sri Balaji Impex (SNG) Pte. Ltd., Singapore for consideration of INR 30 crore.

Upon completion of the above sale, Tern Distilleries will cease to be a subsidiary of the Company.
