Execution of agreement in relation to sale of all the shares held by the Company in Tern Distilleries Private Limited.

United Spirits Limited (“**Company**”/ “**USL**”) has entered into a definitive agreement for sale of its entire shareholding in its wholly owned subsidiary Tern Distilleries Private Limited (“**Tern Distilleries**”), to Sri Balaji Impex (SNG) Pte. Ltd., Singapore for consideration of INR 30 crore.

Upon completion of the above sale, Tern Distilleries will cease to be a subsidiary of the Company.
