THE Enforcement Bureau CID of Tamil Nadu police on Friday busted a racket involved making spurious liquor made with arrack sourced from Pondicherry and mixing it with colouring agents, and selling it through a Tasmac bar in Thanjavur.

Police said Syed Ibrahim (46) was arrested from his house in Kumbakonam when he was loading 500 bottles of spurious liquor in his car.

On investigation, the team led by inspector J Raman found that the accused had purchased arrack from Pondicherry in bulk, mixed it with a colouring agent, bottled it in empty MFPL bottles and gave it to Tasmac shops with fake labels and holograms.
