(*) The 'Corporate Insolvency Resolution Process' (CIRP) has been initiated by Hon'ble National Company Law Tribunal (NCLT), Kolkata Bench vide its order dated November 21, 2019 in respect of M/s Transafe Services Limited (TSL), under the provisions of "The Insolvency and Bankruptcy Code, 2016" (IB Code). As directed by the Insolvency Resolution Professional (IRP), the powers of the Board of Directors of TSL stands suspended as per Section 17 of IB Code from the order date and such powers are now being exercised by the IRP appointed by the Hon'ble NCLT. Consequent to the same, the company ceases to have joint control or have any significant influence over TSL and TSL ceases to be a Related Party of the Company under the extant provisions of Section 2(76) of the Companies Act, 2013 or under IND AS-110 or under Clause 2(1) (zb) of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 for the Year/Period ending 31.03.2020/30.09.2020 does not include figures pertaining to TSL.
