**NOTES:**  
1. The Company's operations were impacted by the second wave of the Covid-19 pandemic and the recovery was seen in the later part of the quarter ended June 30, 2021. Based on its assessment of business / economic conditions, the Company expects to recover the carrying value of its assets. The Company will continue to evaluate the pandemic related uncertainty arising from the on-going second wave and update its assessment.  
2. The unaudited financial results prepared in accordance with Indian Accounting Standards (Ind AS) for the quarter ended June 30, 2021 have been reviewed by the Audit committee and approved by the Board of Directors of the Company at its meeting held on August 3rd, 2021. The sale have also been subject to Limited Review by the Statutory Auditors.  
3. The company's main product lines are in gear cutting tools which contributes over 90% (previous year 90%) of its revenue. The contribution from the balance operation is mostly involving common processes and use of the same machineries of main product lines and thus the company's operations is considered as a single segment.  
4. The Company has no subsidiary, joint venture or associates, hence consolidation of results are not required.  
5. The Figures for the quarter ended 31st March, 2021 represents the difference between the audited figures in respect of full financial year and the published figures of nine months ended 31st December, 2020. The company does not have any Exceptional item to report for the current quarter.  
6. The figures for the previous periods have been regrouped / rearranged wherever necessary.
