Further to our letter No.OCTL/SEC/037/2022 dated December 30, 2022 we regret to inform that we have so far not received confirmation from Bombay Stock Exchange (BSE) that the Company's Scrip Code:500313 has been delisted from BSE and that the trading has stopped. Infact we have observed that the trading is still going on as on January 16, 2023.

In this connection, please be informed that the exchange is aware that as per SEBI (LODR) Regulation 6(3) exchange shall dispose the application for delisting within a period not exceeding thirty days. Though the application was made almost two months back the exchange has not taken any action to delist the Company's Equity Shares Scrip Code.500313, despite several reminders referred above.

The Company has also informed vide its letter No.OCTL/SEC/037/2022 dated December 30, 2022, that the Company shall comply in respect of National Stock Exchange (NSE) only since the trading of Company's Equity Shares will continue to be traded at NSE after delisting from BSE.

We once again request BSE to please confirm per return that the delisting of Company's Scrip Code.:500313 has been delisted from the BSE and trading stopped forthwith. Please be also informed that the listing agreement dated 18<sup>th</sup> February 2016 executed with Bombay Stock Exchange stands rescinded with immediate effect.

We once again request BSE to please confirm per return that the Company's Scrip Code.500313 has been delisted from BSE and trading stopped forthwith.
