KFin Technologies Limited (KFintech), (Service Provider), has provided a system for recording the electronic votes of the Shareholders on all the items of the Special businesses sought to be transacted as per the Notice of the Postal Ballot. The Service Provider had set up e-voting facility on their website https://evoting.kfintech.com/.

The notice dated November 3, 2022, as confirmed by the Company in respect of the below mentioned resolution was sent through electronic mode to those members whose email addresses are registered with the Company/ Depositories, in compliance with the MCA and SEBI Circulars.

We hereby submit our report as under:

- 1. The remote e-voting period remained open from 09.00 A.M. (IST) on November 09, 2022 to 17.00 Hours (IST) on December 08, 2022. Upon conclusion of the e-voting period, the E-voting votes were unblocked on December 08, 2022 at 17:00 hours, in the presence of two witnesses' Mr. Jayesh Khatri and Mr. Nihar Eluri, who are not in employment of the Company.
- 2. The Company had only provided Remote E-Voting facility to the shareholders, to cast their vote.
- 3. The Shareholders as on November 4, 2022, the cut-off date is entitled to vote electronically on the proposed resolutions contained in the notice of the Postal Ballot.
- 4. On completion of voting at the Meeting, the Service Provider, KFin Technologies Limited (KFintech) provided us with the List of Members who had cast their votes, with their holding details and details of vote on each of the Resolutions.
