Sub: Scrutinizer's Report on Passing of Resolutions through Postal Ballot with evoting facility-Postal ballot Notice dated 30.05.2023

We, A.J.Sharma & Associates, Practicing Company Secretaries, Hyderabad were appointed as Scrutinizer by the Board of directors of VBC Ferro Alloys Limited by a resolution passed at their meeting held on 30<sup>th</sup> May 2023 for the purpose of scrutinizing the Postal Ballot Process with e-voting facility and for ascertaining the requisite majority on the resolutions passed as contained in the Postal Ballot notice dated 30<sup>th</sup> May 2023 with e-voting facility carried out as per the provisions of Section 108 and 110 of the Companies Act 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules 2014.

The management of the Company is responsible to ensure the compliances with the requirements of the Provisions of the Companies Act 2013 and Rules relating to voting through electronic means and Postal Ballot on the Resolutions as set out in the Postal Ballot Notice. My responsibility as a Scrutinizer for the voting process is restricted to ensure that the process of Postal Ballot with e-voting is conducted in a fair and transparent manner and make the Scrutinizer's Report of the votes cast "in Favor" or "Against" the resolutions. I have made this report based on the scrutiny of the postal ballots (through e-voting) received from the members and on the reports generated from the e-voting system provided by the Central Depository Services (India) Limited (CDSL), the Authorized agency to provide e-voting facility appointed by the Company.

The Company's Registrars and Transfer Agents M/s Venture Capital & Corporate Investments Private Limited with whom the Company has entered into a tripartite agreement for the e-voting along with CDSL has sent the notice of the Postal Ballot together with the explanatory statement containing material facts to all the eligible shareholders whose e-mail ID's were available. The members of the Company as on the cut off date of 16<sup>th</sup> June 2023 were entitled to vote on the resolutions as contained in the Postal Ballot notice.



Further to the above I report that the Company has published a public notice under Rule 22(3) of the Companies (Management and Administration) Rules 2014 by way of an advertisement on 21<sup>st</sup> June 2023 in Financial Express and Ninadam News Papers (English and Telugu)

The Postal Ballot with e-voting facility remained open from 22<sup>nd</sup> June to 21<sup>st</sup> July 2023. At the end of the voting period on Friday the 21<sup>st</sup> July 2023 at 5.00 P.M the voting portal of the service provider was blocked.

On 22<sup>nd</sup> July 2023 the votes cast through e-voting was duly unblocked by me in presence of two witnesses who are not in the employment of the Company as required under clause 3(xi) of Rule 20.

All the electronic ballot forms received up to the closing hours of 21<sup>st</sup> July 2023 being the last date and time fixed for voting by the Company were considered for my scrutiny.

There after the details containing the list of shareholders who voted "for" or "against" were downloaded from the e-voting web site of CDSL and the report of e-voting was generated and compiled, the details of which are as under.

There was no Postal Ballot Form required to be received physically in view of MCA/SEBI Circulars referred to in the Postal Ballot Notice.
