Govt initiates action...

The GAD letter said that the information of category wise vacancies at district level, divisional level and state level under concerned department should be sent in excel on given e-mail and in hard copy by September 23.

Ruckus in Assembly...

However, in wake of 15 notices from the Opposition a discussion should take place first followed by the CM's reply. However, home minister Nitendra Mishra, PWD minister Gopal Bhargava and Urban Administration minister Bhupendra Singh said Opposition was free to ask questions as had happened several times in the past after the CM's reply but the Opposition members were not ready to accept either the view of the treasury benches or the ruling of the speaker.

In his statement the CM said, "The report which is being referred to as a CAG report is not a CAG report but a draft report prepared by the Accountant General, Madhya Pradesh." He said the draft report of the Accountant General was for the period from 2010 to 2023 which includes 15 months of the then Congress government. He said out of the 94 challans mentioned in the report, 81 pertained to the tenure of the Congress government and the rest to the BJP government.

He said in March 2018 the BJP government had entrusted the reins of nutritional food to the women self-help groups of the state by ending private companies from the nutritional diet system. But the then Congress government decided in November 2019 that these plants should be taken back from women self-help groups and given back to MP Agro. His party colleague Pooja Thakur joined him and said the BJP rallied by the Bharat Jodo Yatra, had organised 'Operation Khambe' (modi) in the coastal state. The BJP retained power in the coastal state after the state Assembly election in February this year. It has 20 MLAs in the Assembly, while the Congress strength will be depleted from 11 to three.

The eight Congress MLAs - Kamal, Michael Lobo, Dehesh Lobo, Ramesh Chandra, Gauri Alemao, Altonio Anonikar, Alexio Sequiera and Rudolf Fernandes - were interacting with Kamal in a viral photo Lobo said of formally joining the BJP.

Michael Lobo said the MLAs took the decision to strengthen the Congress Legislature Party meeting here in merger with the BJP. Lobo said. The three MLAs who did not wish to join BJP, Gauri Alemao, Altonio Anonikar and Carlos Alvares Ferreira - were not present at the meeting and said they would stay with the party.

The party is not dependent on MLAs Congress will remain firm in the state even if the MLAs have left it," Alemao said. "We are giving our word that we will be with the party and will remain strong. We are not some commodity that can be purchased, is a leader. Stating that prior to the elections Congress candidates had taken an oath not to defect, Alemao said, "I don't know how someone can defy God." Carlos Alvares Ferreira said the eight MLAs could not be said to have merged with the BJP "if they have merged Congress into the BJP then which party we (three) belong to," he asked.

PARTHA'S BAIL PRAYER REJECTED

A special court in Kolkata on Wednesday rejected the bail prayer of arrested farmer West Bengal minister Partha Chatterjee and sent him to judicial custody for a two more weeks. It rejected on August 12, 2022, the bail prayer of arrested Partha Chatterjee for 14 days. Judge Hridaytaran Roy granted permission to Partha Chatterjee to the two accused in the corruption cases they are lodged in and to record their statements. Opposing the bail prayer, ED counsel Phiroze Kadamji claimed before the court that arrested Partha Chatterjee has not been covered in cash and assets of Mukherjee. Chatterjee was produced before the court through the virtual mode from Presidency Court, Kolkata, while his lawyers were present before the judge physically.
