Sub: Outcome of the Board meeting held on May 29, 2024

We wish to inform you that the Board of Directors had at their meeting held on May 29, 2024, *inter alia*, transacted the following items of business.

- 1. Approved the Audited Standalone and Consolidated Financial Results of the Company as per Indian Accounting Standards (IND-AS) for the quarter and financial year ended March 31, 2024.
- 2. Took on record the Audit Reports issued by the Auditors on the Audited Standalone and Consolidated Financial Results of the Company for the quarter and financial year ended March 31, 2024.
- 3. Board has reviewed the B-80 Block status. After the clean-up of the reservoir of D1 well, both the wells are activated. However, due to the blockage of the oil export flowline due to wax deposition, both the wells could not be tested to the optimum flow rate. Equipment and personnel are being mobilised for steam and hot water flushing of the line with estimated period of about 7 days shutdown of the field, after which both wells will again be put on production, with due intimations to the stock exchanges.
- 4. Approved amendments in Company's Policy for disclosure of event or information and determination of materiality.
