New Delhi: Findings of the SIT report into the Lakhimpur Kheri farmer deaths kept Parliament on the boil on Wednesday with opposition parties demanding the immediate sacking of junior home minister Ajay Mishra Teni.
Both Lok Sabha and Rajya Sabha were unable to transact much business owing to opposition protests. Lok Sabha functioned for barely 40 minutes as Congress and DMK MPs stormed the well of the House demanding discussion on Lakhimpur Kheri.
The morning hours saw Congress MPs waving newspaper reports in the House and demanding that Speaker Om Biriya admit notices for adjournment motion moved by Rahul Gandhi and other opposition members.
Pleas by parliamentary affairs minister Pralhad

He also posed a discussion on the subject of price rise, saying it was a burning issue that opposition MPs had demanded a discussion on.
Congress and DMK leaders, however, poured into the well of the House raising slogans of 'Modi Sarkar hai hai', leading Rajnath Agarwal to adjourn the House for the day.
Rajya Sabha was adjourned for the day following three earlier adjournments as Opposition continued to

raise slogans demanding the revocation of suspension of 12 MPs. Opposition forced 15-minute adjournment in Rajya Sabha when the cabinet minister was present, which is the "accepted practice". Later, Congress whip Jairam Ramesh said this demonstrated Modi government's "absolute contempt for Parliament".
Meanwhile, Rahul, after being denied an opportunity to move an adjournment motion or speak in Parliament addressed the press outside the House. He said Congress will not relent until the government sacks Teni and Rajya Sabha members for hatching a criminal conspiracy to "murder" innocent protesting farmers in Lakhimpur Kheri.
Rahul said he promised the people there that we will ensure justice done. So, we will not back down until that happens Rahul said.

'Punjab toll siege on until hike withdrawn'

Bathinda: Most farmer unions of umbrella group Samyukt Kisan Morcha (SKM) led forces on Wednesday with Bharatiya Kisan Union (Bharatiya Kisan Union (BKU) to continue with the protests at road toll plazas in Punjab until the revised rates were withdrawn. The rate went up after the protest against the farm laws.
The BKU asked the state government and the toll companies on Tuesday to withdraw the revised toll. It sought a decision by Wednesday afternoon, by which time other farmer unions announced not to vacate protest sites along roads until a rollback. The other sites of protest against farm laws were vacated after 44 days, following the Centre rescinding all three laws this week.

BKU will meet the issue at a meeting with CM Charanjit Singh Channi on Thursday and hold a state-level meeting on Friday.
Punjab has 25 toll plazas on highways and collected about Rs3 crore every day before the start of the blockades in October last year. The toll companies are protesting against the farm laws.

The bill also seeks to make gender-neutral a provision allowing only the wife or the spouse of the registered voter as a voter in the same constituency as him.
A fourth amendment seeks to empower the Election Commission to call for the premises for any purpose related to elections and not just for creating polling stations and storage of ballot boxes. Sources said the Bill would amend the RP Act to empower the electoral registration officer to seek Aadhaar number of existing as well as new voters, albeit only on a voluntary basis. The service voter will only be used for the purpose of voter authentication.

While the multiple dates for registration of newly eligible voters in Section 14(d) of the Act, the gender-neutral registration facility for spouses of service voters is sought to be implemented by amending Section 20(6) of the Act.
