L&T Construction Awarded (Significant) contract for its Heavy Civil Infrastructure Business

Mumbai, 9th March 2022: The Heavy Civil Infrastructure business vertical of L&T Construction has won a significant order from the prestigious Delhi Metro Rail Corporation Limited (DMRC), to design and construct the Underground Metro Project of Phase-IV of Delhi MRTS.

The major scope of work for the project comprises Design and Construction of 5 Km of Twin Tunnel (Up & Down Line) by Shield Tunnel Boring Machine (TBM), Cut and Cover Tunnel box, Underground Ramp and four Underground stations namely Chhattarpur, Chhattarpur Mandir, IGNOU and Neb Sarai with associated works of Aerocity to Tughlakabad Corridor of Phase-IV of Delhi MRTS.
