
## 52-year-old man killed with backhoe in Kuha village

Ahmedabad: Two men killed a 52-year-old farmer by running him over with a backhoe at Kuha village about 10km from Ahmedabad, when he and his family tried to stop them from excavating soil from their farm late on Thursday night.

The victim, Kanti Thakor, 52, felled a field next to a piece of gauchar (village commons) land in Kuha.

Thursday evening, the women of the family went near the field to collect firewood and saw some men excavating soil, which they informed the men about.

Kanti with his brothers and cousins - Chandubi, Somaji, Shailesh, Jignesh, Galajji, Jashu, Vinesh and Ramesh - reached the field at about 8pm, where two men on a backhoe were filling



themselves. Kanti's brother Shailesh was hit with the rear bucket. He also suffered injuries. The men then drove the backhoe to Bhadra village, abandoned it and fled in an SUV, the FIR filed at Kanthal police station says.

Rajkot: The city's posh Kalavad Road will be widened and converted into a six-lane.

The decision was taken in the Rajkot Municipal Corporation's (RMC) standing committee meeting held on Saturday. The decision was taken considering the massive increase in the number of cars and two-wheelers in the city and the frustrating traffic jams witnessed on this important road. The accused are on the run, and we have seized the backhoe," said Kalatra. Kantha police have registered a complaint for murder.

## Capital's poor case-solving score

Ahmedabad: Gandhinagar, Gujarat's capital, its political and bureaucratic hub and the city which houses Police Bhawan, ironically holds a poor prevention and detection record when it comes to thefts and burglaries. Data shows

that 154 burglaries were reported till September 2023 of which only 43 were detected, taking the crime-solving rate to just about 28%.

uncertainty prevails over Indian military presence. On an average, Gandhinagar has registered around 150 burglaries every year from 2018 till September 30, 2023.
