- Other Comprehensive income for the year ended March 31, 2019 includes realised gain of Rs. 120.97 lakhs (Rs. 120.97 lakhs for the quarter ended on March 31, 2019) on the sale of investments.
- The IND AS 115 Revenue from Contract with customers, mandatory for reporting periods beginning on or after April 01, 2018, replaces existing revenue recognition requirements. The application of IND AS 115 has not impacted the company's accounting for recognition of revenue.
- The figures for the quarter ended March 31, 2019 and March 31, 2018 arc the balancing figures between the audited figures in respect of full financial year
- 5 ended March 31, 2019 and March 31, 2018 and unaudited published year to date figures upto the nine months of the relevant financial year which were subject to limited review by the Statutory Auditors.
- 6 Figures of the previous financial period / year have been re-arranged / re-grouped / reclassified wherever necessary.
- 7 The Company operates in only one segment namely "Property and Related Services".
- A Scheme of merger by way of absorbtion of Star Shopping Centres Private Limited (a Subsidiary of the Company) by the Company was filed with National Company Law Tribunal on May 15, 2018.
