Five persons, including two married couples and a teen girl, drowned in the Narmada canal near Gundala village in Kutch district Monday evening, police said. "The bodies of the two women, the 15-year-old girl and two men have been found," the police officer added.

Morbi bridge collapse: HC likely to take up suo motu PIL today

THE GUJARAT High Court is likely to hear the suo motu PIL on the Morbi bridge tragedy Tuesday, as the matter was not taken up Monday because of the unavailability of the bench headed by Chief Justice Aravind Kumar.

The division bench of Chief Justice Kumar and Justice Ashutosh Shastri had issued notices to the state government and the Human Rights Commission on November 7 on the October 30 tragedy and sought a status report from the government. As per the HC's website, November 15 is the next listing date for the case.

The collapse of the Britishera suspension bridge on the Machchhu river in Morbi on October 30 claimed 135 lives,

including women and children. The HC said on November 7 that it had taken suo motu (on its own) cognisance of a news report on the bridge collapse tragedy and registered it as a PIL

(Public Interest Litigation).

It directed the registry to implead the Gujarat government, represented by its chief secretary, state home department, commissioner of municipalities, Morbi municipality, district collector and State Human Commission. "Respondents 1 and 2 (chief

secretary and home secretary) shall file a status report by next Monday. The State Human Rights Commission shall file a report in this regard by the next date of hearing," the court had said in its order.

Nine persons, including four from the Oreva Group, were arrested on October 31.

Cong candidate among 345 affected by food poisoning after religious event

MORETHAN 345 people, including Vagra Congress candidate Suleman Patel, have been infected with food poisoning after attending a religious gathering organised in Chanchvel village of Vagra taluka in Bharuch Sunday.

While the Congress leader was discharged Monday morning, two children are currently undergoing treatment at Bharuch civil hospital. The villagers complained of vomiting, diarrhea and stomach ache soon

As word spread, Bharuch district health officials sent four teams of doctors and paramedical staff who organised a camp

where primary treatment was given to those with mild symptoms. Those patients who had serious complications were shifted to government and private hospitals. "Our teams at the health

camp gave OPD treatment to 152 patients, including minors. Around 118 patients were shifted to different hospitals, including 18 to Bharuch Civil Hospital (where two are still ad-

mitted), 67 patients to Vagra Community Health Centre (CHC), 48 in Amod CHC, 39 in a private hospital in Jambusar, and 15 in private hospitals in Bharuch," said Bharuch district health officer Dr JS Dhulera.

Collector Tushar Sumera visited the patients in Bharuch Civil Hospital. A Food and Drugs Department team also reached the village and took samples of the leftovers which were sent to the laboratory for tests. "We are awaiting the report of the Food and Drugs department, so that further steps can be taken," Dhulera said.

Youth held with narcotics worth Rs 2.17 crore in Surat

A YOUTH was arrested from the **Surat Municipal Corporation** EWS quarters Monday after the police seized 2.176 kilograms mephedrone worth Rs 2.17 crore from him.
