डेट फंडों ने जी-सेक में निवेश बढ़ाया

सरकारी प्रतिभूतियों का बढ़ा आकर्षण



कॉर्पोरेट चुक कर आकर्षण और बैंकों द्वारा जमा पत्रों (सीडी) निर्माण में गिरावट को वजह से डेट य्यूचुरल फंडों ने पिछले साल के दौरान सरकारी प्रतिभूतियों (जी-सेक) में अपना निवेश 30 प्रतिशत तक बढ़ाया। बाजार नियामक सेबी द्वारा सुरक्षा करार ग्राहकों के अनुसार, जी-सेक के लिए निवेश एक साल में 94.215 करोड़ रुपये या 31 प्रतिशत तक बढ़कर आमतौर पर अंत तक 3 लाख करोड़ रुपये हो गया।

परिपक्व हो रहे पत्रों का 27,997 करोड़ रुपये का योगदान है। सार्वजनिक क्षेत्र के बैंकों/डिपॉजिट बैंकों में आवंटित पिछले साल के 2.20 लाख करोड़ रुपये से बढ़कर आमतौर पर 2.40 लाख करोड़ रुपये हो गया था।

उन्होंने कहा, 'सूकूम' में, डेट फंडों का इस्तेमाल बैंक सीडों में निवेश के लिए किया जाता था, लेकिन अब उनके द्वारा जारी पत्रों की संख्या ज्यादा नहीं है, क्योंकि वे स्वयं पचास परसेंट से संपन्न हैं। इसके अलावा, आईएफडीएफएस संकट के बाद से ऋण बाजार प्रभावित हुआ है, इसलिए फंड सरकारी प्रतिभूतियों में निवेश कर रहे हैं।

■ **आईएलएडएफएस संकट के बाद से ऋण बाजार प्रभावित हुआ है, जिससे फंड सरकारी प्रतिभूतियों में निवेश कर रहे हैं।**

■ **हालांकि अभी भी, फंड हाउस एएन-से कम रिटेंटिंग के ऋण पत्रों में निवेश से परहेज करते हैं।**

डेट (सीडी) में भी अपना निवेश बढ़ाया। अगरतक, फंड प्रबंधकों के पास एनबीएफसी के सीपी में 75,0243 करोड़ रुपये निवेश था, जबकि पिछले साल यह आंकड़ा 49,090 करोड़ रुपये था। वहीं एनबीएफसी के सीडी में यह निवेश जहां आमतौर पर 86,104 करोड़ रुपये था, वहीं इस साल बढ़कर 92,377.85 करोड़ रुपये हो गया।

विश्लेषकों का कहना है कि कई डेट फंड अभी भी लिक्विड प्रतिभूतियों में निवेश परदेर करते हैं, क्योंकि वे 2018 के बाद से लिक्विड चुक और ऋण पत्रों को डाउनग्रेड देख चुके हैं।

हार्डटैक इएजोस्टिक के अधिग्रहण को मेट्रोपोलिस से मंजूरी

स्वास्थ्य स्थिति का पता लगाने के लिए जांच कर चलाने वाली प्रमुख कंपनी मेट्रोपोलिस हेल्थकेयर ने शुक्रवार को कहा कि उसके निदेशक मंडल ने 636 करोड़ रुपये में हार्डटैक इएजोस्टिक सेंटर और उसकी सहायक इवाई सेंट्रल हेल्थकेयर के अधिग्रहण को मंजूरी दी है। इससे पहले 17 जनवरी, 2021 को मेट्रोपोलिस हेल्थकेयर ने स्टॉक एक्सचेंज को दी सूचना में कहा था कि उसके निदेशक मंडल ने नकर और इन्वेंट्री कोड के सीडी में हार्डटैक इएजोस्टिक सेंटर और उसकी सहायक इवाई सेंट्रल हेल्थकेयर सॉल्यूशंस के अधिग्रहण को मंजूरी दी थी। निदेशक मंडल ने पहले आधिकारिक रूप से 511 करोड़ रुपये के हिस्से में 4,95,000 पूर्ण रूप से हार्डटैक इएजोस्टिक को हिस्सेदारों के साथ अधिग्रहण को मंजूरी दी थी। 'मेट्रोपॉलिस हेल्थकेयर ने कहा, 'निदेशक मंडल ने 17 जनवरी, 2021 में शेर खरीद समझौते की नियमों और शर्तों में संशोधन को मंजूरी दे दी है।'

वित्तीय शेरों पर उत्साहित फंड प्रबंधक

फंड प्रबंधक इक्विटी-आधारित योजनाओं में मजबूत प्रवाह के बीच उत्साहित हैं। एस्वीआई लाइफ, एस्वीआई काइर्स और एक्सिस बैंक उन शेरों में शामिल थे, जिनमें ज्यादा निवेश शामिल हुआ था। एक महीने के दौरान इन शेरों में 5,200 करोड़ रुपये का निवेश आकर्षित हुआ। मेकर हेल्थकेयर इन्वेंचर ने 1,992 करोड़ रुपये का सर्वाधिक निवेश शामिल किया, भले ही यह शेर स्टॉक में करीब 7 प्रतिशत की गिरावट का शिकार हुआ। (किसी इक्विटी कंपनी के शेयरों में इन्वेंचर करीब 7 प्रतिशत का निवेश घटाया, जिससे फंड प्रबंधकों को इस शेर में अपना निवेश बढ़ाने का मौका मिला।) मिडिकैप श्रेणी में दोषाफोन आइडिया में अग्रणी खरीदारी हुई और उसका शेयर दस गुना बढ़ने के लिए सरकारी सहाय के बाद करीब दो गुना गया। उसके अलावा भारत कोज और बाटा इंडिया में भी तेजी दर्ज की गई।



स्मॉलकैप श्रेणी में, कैज फिन होमस और अरविंद फेशन जैसा खरीदारी वाले शेर थे। इन बीच फंड प्रबंधक आईआरसीटीसी में मुनाफावसूली करते दिखे। सरकार के स्वामित्व वाली इस कंपनी का शेयर इस साल करीब चार गुना बढ़ा है। भारत की एयरटेल में उसके राइट इश्यू से पहले 5,225 करोड़ रुपये की बिक्रियाती हुई। विश्लेषकों का कहना है कि फंड प्रबंधकों ने उसके राइट इश्यू को खरीदने के लिए अपने शेरों की बिक्री की। एस्वीआई लाइफ और रिटायर्स इंडस्ट्रीज (अरआईएल) भी ज्यादा बिक्री वाली सूची में शामिल रहे। मिडिकैप और स्मॉलकैप श्रेणी में कैम्स और ग्रेजुअल इंडिया जैसा विपरीत वाले शेर थे। सिटिवर में इक्विटी एमएफए ने 8,670 करोड़ रुपये का प्रवाह आकर्षित किया, जबकि उन्होंने शेरों में 7,100 करोड़ रुपये लगाए।
