In terms of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") as amended from time to time, we hereby inform that **JBM Ecolife Mobility Private Limited, a subsidiary of JBM Auto Limited, has been awarded the Tender for end-to-end execution of 1,021 [One thousand twenty one] Electric Buses and development of allied electric and civil Infrastructure on Gross Cost Contracting [GCC] under the PM-eBus Sewa Scheme (Tender-II).** The project will be supported by a Payment Security Mechanism (PSM), ensuring timely payments to electric bus operators and enhancing financial sustainability for industry stakeholders. **The approximate order value of the tender stands at Rs. 5,500 Crore (Rupees Five Thousand Five Hundred crore). These e-buses will be deployed in around 19 cities across Gujarat, Maharashtra and Haryana.** The Company has received on 18<sup>th</sup> February, 2025, the Letter of Confirmation of Quantities eligible for award as issued by Convergence Energy Services Limited [CESL].
