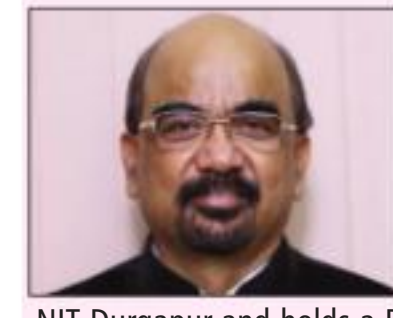
### Blue Star unveils new products & solutions with Virus Deactivation Technology (VDT)
