NATSOFT Information Systems Pvt Ltd, a member of the promoter and promoter group of NATCO, which holds 8.67 % in NATCO to (i) Mr. Rajeev Nannapaneni (his son and a member of the promoter and promoter group of NATCO) and (ii) Vistra ITCL India Limited, a trustee of VCN family Trust (Vistra ITCL India Limited is recognised as a member of the promoter and promoter group of NATCO). After the proposed transfers, there will be no change in the promoter and promoter group holding of NATCO.


