Gurugram, Nov 03, 2023: Whirlpool of India, today announced operating results for the second quarter and H1 of FY 2023-24. H1 Consolidated Total revenue from operations at **Rs 3560.2Cr lower by 3.6% vs. LY,** H1 Consolidated EBITDA at **Rs. 196.5Cr lower by 11% vs LY,** H1 Consolidated PBT at **Rs.150.9Cr lower by 16.7% vs. LY** and H1 Consolidated PAT at **Rs.114.9Cr lower by 14% vs LY**.

Q2 Consolidated Total Revenue from Operations at Rs 1521.6Cr, lower by 5.6% vs LY; Q2 Consolidated EBITDA at Rs.73.1Cr, down by 17.8% vs LY; Q2 Consolidated PBT at Rs. 52.3Cr lower by 21.9% and Q2 Consolidated PAT at Rs. 38.2Cr lower by 22.1% vs LY.

Mr Narasimhan Eswar, Managing Director Whirlpool of India Limited said, We delivered a marginal volume increase in a competitive yet flattish market. Revenue is lower by 5.6% vs last year due to down pricing action taken in the early part of the calendar year to aid competitiveness. Profitability is affected due to pricing and impact of regulatory changes in this calendar year. Elica India* business is trending well.
