- 1. The dispatch of the Postal Ballot Notice dated February 11, 2020 was completed on February 20, 2020 to the Members whose names appeared on the Register of Members/ List of Beneficial Owners as received from Central Depository Services (India) Limited (CDSL) as on February 11, 2020. The Postal Ballot Notice was sent to the Members in electronic form to the email addresses registered with their Depository Participants (in case of electronic shareholding)/the Company's Registrar and Share Transfer Agents (in case of physical shareholding). For Members whose email IDs were not registered, physical copies of the Postal Ballot Notice were sent by permitted mode along with a postage-prepaid self-addressed Business Reply Envelope.

- 3.1 Particulars of all the postal ballot forms received from the members and votes cast through electronic means have been entered in the register separately maintained for the purpose.
- 3.2 The postal ballot forms were kept under my safe custody before commencing the scrutiny of such postal ballot forms.
- 3.3 The votes cast through electronic means were unblocked on March 21, 2020 at 8.01 P.M. The postal ballot forms were scrutinized on 23rd March, 2020 at ICDS Limited Manipal,
- 3.4 The postal ballot forms and votes cast through electronic means were scrutinized and the shareholding was matched/confirmed with the Register of Members of the company / list of beneficiaries as on Friday, February 11, 2020.
- 3.5 All postal ballot forms and votes cast through electronic means received up to 5.00 pm (IST) on March 21, 2020 being the last time and date fixed by the company for receipt of the forms and votes cast through electronic means were considered for my scrutiny.
- 3.6 No envelope containing postal ballot form was received after March 21, 2020 up to the date of this report.
- 3.7 Few envelopes containing postal ballot forms were returned undelivered.
- 3.8 I did not find any defaced or mutilated ballot paper.
- 3.9 The remote e-voting was unblocked in the presence of two witnesses who are not in the employment of the Company.
- 4. A summary of votes cast through postal ballot and votes cast through electronic means is given in Annexure I.
