Brief Profile of Dr. Punita Kumar-Sinha

Dr. Punita Kumar-Sinha holds a Ph.D and a Masters in Finance from the Wharton School, University of Pennsylvania, undergraduate degree in Chemical Engineering with distinction from the Indian Institute of Technology, New Delhi, an MBA degree from Drexel University and also a CFA Charter holder. She is a member of the CFA Institute and the Council on Foreign Relations. Dr. Kumar-Sinha is the Founder and Managing Partner, Pacific Paradigm Advisors, an independent investment advisory and management firm. Prior to founding Pacific Paradigm Advisors in 2012, she was Head of Blackstone Asia Advisors L.L.C. and its Chief Investment Officer, and was a Senior Managing Director of The Blackstone Group L.P.

She has 30 years of experience in fund management in emerging markets, being one of the first foreign investors into India. Before joining Blackstone, she was a Managing Director at Oppenheimer Asset Management Inc., Portfolio Manager and Chief Investment Officer at The India Fund Inc., and Asia Tigers Fund Inc., and Senior Portfolio Manager at CIBC World Markets. She has also been a Portfolio Manager on the emerging markets team at Batterymarch (a Legg Mason company), and on the international equity team at Standish Ayer & Wood (a Bank of New York Mellon company). She is also on several other Boards and has numerous years of experience in corporate governance.
